



<b>FORMS</b>	<b>PETITION FOR PROBATE GUARDIANSHIP OF THE PERSON</b>
<b>Revision Date</b>	August 10, 2023
<b>Purpose</b>	These forms are used to ask for guardianship of the person. Guardianship of the person is where the court appoints an adult person (not the parent) to have custody, make decisions and care for a minor child.
